Randy Dangerfield - Welcome

- 1) 2010 Annual meeting minutes reviewed and approved
- 2) 2010 Financial Report approved-Question asked concerning the USDA Forest Service permit fee. This fee is for the use of the roads and water lines within the association boundaries. The association was suppose to have been paying these fees all along but was an oversight by the Forest Service.
- 3) Forest Service Representative unable to attend due to budget cuts-Jeff Ward 435-654-0470

Palmer DePaulis - Wasatch County Fire District requirements for 2011 (hand out). Need to work on turnouts and hammer heads (5 loads of gravel needed this year) and continuous need to brush-out sides of roads (use brush cutter). We need to remove large brush 20'off the road. Met with Jerry Davis (Fire Marshall) they are very happy with our progress. They asked that we look into a way for Emergency Vehicle to access the gate (opener that responds to frequency of vehicle horns). It was agreed to set aside \$500 for future possible need for a gate security system.

John Quick (Water Committee)- This past year the chlorinator needed a new battery. Wasatch County has reviewed our system and recommended some things that need fixing and it is being worked on.

David Summers (Water Master) - Documentation is being done of the location of all valves. A portion of this has been completed showing latitude and longitude for each. This will be put on AutoCAD prpgram when finished. Cross connections to be documented and replace where needed. Gravel needed on road to water tanks. Cary Dunn suggested a diversion ditch to prevent road being washed out. Question asked whether water could be turned off later in the year and the By-Laws state the 1st week in October. If it is done any later, there could be chance of freeze which would cause major problems.

Randy Dangerfield discussed progress on the replacement of water lines. Work days will be used to finish up water lines, burying any exposed blue pipe, replacing a few boxes and vaults, cross connections, etc. There are still some sections that have not been completed and we will work on those at the first workday in June. Some of the areas that need attention are by #17 to #16, and #29 and #24. It was also decided that any surplus pipe be returned to Ferguson Plumbing for a refund.
